

Our organization actively engaged volunteers, over the age of fifty, in the Family Match and School Grandparent Programs which helped to promote strong extended families and created a positive learning environment for countless children enrolled in elementary schools in the Lower Mainland.

In addition to the usual program evaluation process (initial, 3 month, 6 month and one year mark of matches), an extensive program evaluation occurred in 2011. This evaluation was a way for all of our program participants (volunteers and parents) to give us feedback on our programs, newsletter, website, the Volunteer Appreciation BBQ and our partnership with Kids Up Front.

We dispersed the Mary Florio Bursary to six different families amounting to a total of \$2,548 bursary dollars and 14 children being sponsored. The funds enabled parents to enrol their children in the following lessons: music education, ski lessons, Science World Camp, Dance Matrix lessons, painting and drawing classes, swimming lessons and skating lessons.

VG nominated Mr. Kehar Singh Aujla for a Seniors of Distinction Award through the Newsleader and Harmony Court. He was a successful candidate and proudly attended the award ceremony in October 2011. His story was covered in both the Burnaby Now and the Burnaby Newsleader.'

Almost 100 volunteers, families and members attended our Volunteer Appreciation BBQ, August 28th, 2011 at Confederation Park in Burnaby. Activities included a three legged race, a bean bag toss and a piñata.
